CONSIDERATION AND ACTION ON A RESOLUTION TO APPROVE A LEASE AGREEMENT BETWEEN THE GAINESVILLE ECONOMIC DEVELOPMENT CORPORATION AND LIBERTY OILFIELD SERVICES, INC. Ryan Morris made the motion to table the resolution until the June 22nd meeting due to lack of finalized contract. Ray Nichols seconded the motion. CONSIDERATION AND ACTION ON A RESOLUTION TO APPROVE COST OF LIVING INCREASES FOR GEDC STAFF IN ACCORDANCE WITH CITY OF GAINESVILLE POLICY. Ryan Morris made the motion to approve the resolution as presented. Philip Neelley seconded the motion. The motion passed. 5 AYES, 0 NAYS, 2 ABSENT, 0 ABSTENTIONS.

RECOGNITION OF INCOMING AND OUTGOING BOARD MEMBERS. Tommy James announced his retirement as a GEDC board member effective June 1st.
